



**SUBJECT**

Application for a Heritage Permit for replacement of nine (9) existing third-storey wood windows with aluminum-clad wood windows.

**DISCUSSION**

The proposed application would see the third-storey wood windows on the eastern, southern, and western faces removed and replaced with black aluminum-clad wood windows to match. Specifically, the four single-hung 2/2 windows on the eastern (front) façade, three of the four single-hung, 1/1 windows on the western (rear) façade and the two single-hung, 1/1 windows on the southern façade will be replaced. There is intent for the third storey to be granted occupancy following future work, with a code-required man-door replacing the fourth window on the rear facade and the installation of a fire escape on the rear of the building. This will be seen on a future permit application.

The windows will match the existing windows in size and style, the only changes being the colour of the windows to black and the operation of the windows as double-hung rather than single-hung. While the window openings have arched heads, neither the existing windows nor the proposed windows have arched heads, and as it is only the third-storey windows that are being replaced, the existing continuity of the window style will be maintained. It is unknown as to whether the existing windows are original. Were all windows on the property being replaced in tandem, Staff would prefer the installation of windows with arched heads.

This is a Rehabilitation project. Standards (I) through (XII) of Section 8 of the *Saint John Heritage Conservation Areas By-Law* apply. While aluminum-clad wood is not a traditional style of window, it has been the precedent of the Board to approve appropriately-styled windows in this material. The proposed work meets the intent of the *Saint John Heritage Conservation Areas By-Law* and the Standards and Guidelines for the Conservation of Historic Places in Canada, as expressed in the Practical Conservation Guidelines for Windows.

### **RECOMMENDATION**

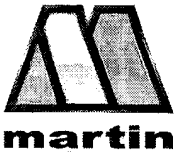
Approve a Heritage Permit to replace nine (9) existing wood windows with new aluminum-clad wood windows.

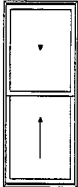

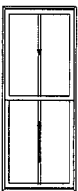

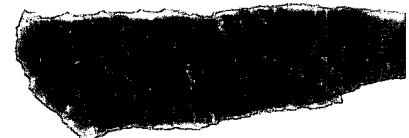
